### **ADMISSION RULES**

**to R.GLIER KYIV MUNICIPAL ACADEMY OF MUSIC in 2019 (as amended)**

#### **XIV. Peculiarities of admission to study at R.GLIER KYIV MUNICIPAL ACADEMY OF MUSIC foreigners and stateless persons**

1. Admission to study at R.GLIER KMAM of foreigners and stateless persons is carried out in accordance with the Laws of Ukraine “On Higher Education”, "On the Legal Status of Foreigners and Stateless Persons", "About foreign Ukrainians", "About refugees and persons in need of additional or temporary protection", Decree No. 271 of the President of Ukraine of June 3, 1994 “On measures for the development of economic cooperation of the regions of Ukraine with the adjacent regions of the Republic of Belarus and administrative-territorial units of the Republic of Moldova”, by Resolutions of the Cabinet of Ministers of Ukraine of September 11, 2013 No. 684 “Some Issues of admission for Foreigners and Stateless Persons”, Order No. 1541 of the Ministry of Education and Science of Ukraine of November 1, 2013 “Some Issues of Organizing of Admission and Training (Internship) of Foreigners and Stateless Persons”, registered with the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536.

2. Foreigners and stateless persons (hereinafter referred to as foreigners) may obtain higher education at the expense of individuals and / or legal entities, unless otherwise provided by international treaties of Ukraine, the consent of which is provided by the Verkhovna Rada of Ukraine, legislation or agreements between institutions of higher education. education on international academic mobility.

Admission of foreigners to R.GLIER KMAM for training at the expense of the state budget is carried out within the limits of quotas for foreigners.

3. Foreigners who come to Ukraine for the purpose of study, enter R.GLIER KMAM for accredited educational programs (specialties).

Enrollment of foreign applicants for study at the expense of individuals and / or legal entities may be carried out by R.GLIER KMAM:

1) twice a year from June 29, before and at the beginning of the academic semester (but not later than November 01), for the degree of bachelor, master;

The terms for submitting bids to the Common database, as defined in clause 6 of Section XV of these Rules, shall not apply to the admission of such foreigners.

R.GLIER KMAM calculates the entry points / grades based on the document on the previous level of education and sets the minimum required for

entry the value of the number of points / grades in the subjects which the entrance test consists of. In R.GLIER KMAM Minimum Contest points for Creative Competition is set at 140 (one hundred and forty) points for foreigners who enter to get master's and bachelor's degrees.

Enrollment of foreigners to study at the appropriate level of higher education is carried out on the basis of entrance examinations in certain subjects and language of study and on the basis of academic rights to continue education provided by the document on the obtained level of education in the country of origin, and taking into account the points of success that entitle to continuing education at the next higher education level in accordance with the law of the country that issued the diploma.

Enrollment of foreigners to study at R.GLIER KMAM is carried out to the first year of the standard term of study according to the results of the creative competition (Stage 1: "Performing a solo program in the specialty") and the language of training (interview in the Ukrainian language).

To enter R.GLIER KMAM the foreigner personally submits to the Admissions Committee:

- a statement in paper form;
  - document (original and copy) on the previously obtained educational level, on the basis of which the entry is made;
  - appendix (original and a copy) to the document on the previously obtained educational level, on the basis of which the entry is made (if any);
  - academic certificate issued by a foreign / Ukrainian educational institution (in case of transfer or renewal to study, starting from the second year);
  - original and a copy of the document, which contains information about the content of the curriculum by previous degree (level) of education, credits received, duration of study and academic achievement (in the absence of this information in the appendix to the education document);
  - a copy of the official document identifying an individual;
- policy of medical insurance, unless otherwise provided by international treaties of Ukraine;
- 4 30 x 40 mm photo cards;
- a copy of the certificate of a foreign Ukrainian (if any).

4. All categories of foreigners entering the study program are enrolled in R.GLIER KMAM based on enrollment orders. Confirmation of the fact of training can be the certificate generated in the Common database.

5. Requirements of R.GLIER KMAM on the eligibility of foreign applicants who arrived in Ukraine for the purpose of study, the conditions of admission to the respective levels of higher education, as well as the deadline for accepting applications and documents, conducting entrance tests, creative competitions ("Performing a solo program in the specialty") and enrollment in the Admission Regulations and are published on the official website of R.GLIER KCAM.

6. Foreigners who are awarded state scholarships under international treaties, national programs, other international commitments of Ukraine are

admitted to training within the established quotas for foreigners on the basis of directions of the Ministry of Education and Science of Ukraine.

7. Foreigners who come to Ukraine to participate in academic mobility programs or to obtain higher education under educational programs agreed between Ukrainian and foreign higher education institutions shall be accepted for training subject to the relevant contractual obligations of the respective higher education institutions.

8. Foreign Ukrainians who are legally resident in Ukraine and whose status is certified by a certificate of a foreign Ukrainian, during the entrance to R.GLIER KCAM have the same educational rights as citizens of Ukraine, with the exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, the consent of which is provided by the Verkhovna Rada of Ukraine.

Foreign Ukrainians, whose status is certified by a certificate of a foreign Ukrainian, can be enrolled in state-ordered training within the established quotas for foreigners in subjects stipulated by the Admission Rules.

9. Foreigners and stateless persons permanently residing in Ukraine, persons granted refugee status in Ukraine, and persons in need of additional or temporary protection and joining R.GLIER KMAM according to the rules set out in these Admission Rules, may participate in competitive selection for public procurement within the limits set by the Cabinet of Ministers of Ukraine on the basis of a special competitive score, which is calculated as the ratio of the entry score determined in accordance with paragraph seven of Section VII of these Rules, to the minimum competitive score of the recommendation on the places of regional order for the general competition for this competitive offer in the previous year (in the absence thereof such a score, a similar indicator is used for another, most closely related, competitive bid within R.GLIER KMAM in case of impossibility- another institution of higher education by the decision of the admissions committee).
